STOP WORK MEETING WEDNESDAY, FEBRUARY 13, 2008

The regular scheduled meeting set for Thursday, February 7, 2008 has been *rescheduled* as a Stop Work Meeting on Wednesday, February 13, 2008 at 7:00 p.m. at ILWU Memorial Hall, 231 W. "C" Street, Wilmington due to the 2008 Contract Caucus in San Francisco.

PRESIDENT'S DAY PAID HOLIDAY

President's Day, Monday, February 18, 2008 is a paid holiday.

Only registered persons who have 800 qualifying hours in the prior payroll year (2007) and meet the availability requirements for at least two (2) of the five (5) days Monday through Friday (exclusive of the day of the holiday) during the payroll week in which the holidays falls will receive a paid holiday for President's Day. This means you must work or meet the availability requirements for at least two days, Tuesday, February 19; Wednesday, February 20; Thursday, February 21 and Friday, February 22, 2008.

Under the current contract, if you worked 1300 hours or more in the payroll year 2007, you do not need to meet the availability requirements to receive President's Day holiday pay.

Anyone intending to take a vacation during the holiday week must report the vacation to the Records Clerk in the Dispatch Hall on or before Friday, February 22, 2008. Any person not receiving holiday pay because of injury, illness, jury duty, etc. must file a claim with the Records Clerk on or before Friday, April 11, 2008. President's Day holiday pay will be paid on March 7, 2008.

Lincoln's Birthday, February 12, 2008 is a holiday but is not a paid holiday. All work performed on Tuesday, February 12, 2008 will be paid at the overtime rate.
